Regarding authorize / renewal for collection / reception / treatment / transport /storage / disposal of Solid Bio-Medical Wastes as detailed below

1. TSBMWMS with consent from Karnataka State Pollution Control Board has established State-of-art Common Bio-Medical Waste Treatment Facility at Site no.31/C, K.I.A.D.B Industrial Area, Machenahalli – 577222, Shimoga Dist., Karnataka State, India.
2. HCF will give its Solid Bio-Medical Waste, properly packed in colour-coded bags as per Pollution Control Board regulation for treatment and final disposal to CBMWTF. The waste should be given at one single point by HCF at given time to CBMWTF vehicle.
3. In case of amputated body parts and dead fetus the HCF must properly pack it in yellow bags only and must give a declaration letter.
4. The exact no. of beds will be taken as per Authorization copy issued by Pollution Control Board.
5. This price will be fixed for one Subscription year and thereafter subject to mutually agreed terms and conditions and may be reconsidered if decided by the Governing Committee.
6. During this one year will HCF not enter into any agreement with any other party or organization for the treatment & disposal of Solid Bio-Medical Waste. HCF Will ensure timely payment to CBMWTF on 10<sup>th</sup> of every month or five working days from the date of submission of bill by CBMWTF.
7. In case of non-receipt of payment on the agreed date from the HCF, CBMWTF will stop the collection of Solid Bio-Medical Waste immediately with intimation to Karnataka State Pollution Control Board. The delayed payments will be collected with interest of 18%. CBMWTF assures and covenants that prompt removal of the Solid Bio-Medical Waste within the stipulated time by it will be the essence of this Agreement.
8. CBMWTF shall give necessary and appropriate instructions to its employees with regarding to the lifting of the Solid Bio-Medical Waste.
9. CBMWTF will issue a proof of waste collection to HCF on regular basis. This will help the HCF's getting compliance with the Pollution Control Board.
10. In case of HCF finds any irregularities in collection of waste they can send intimation in writing to The Shushrutha Bio-Medical Waste Management Society for immediate action.
11. CBMWTF will maintain their plant in good running condition all the time and ensure Continuity of service on all the days without fail. (Except Sundays).This Memorandum of Understanding is entered into on the express understanding that TSBMWMS will maintain and run the facilities and collect, transport and treat the waste at their plant strictly in accordance with the consent of the Karnataka State Pollution Control Board and it shall be their responsibility to obtain the consent.
12. In case of violation of any of the agreed condition of this MOU by either side, issue of notice three months in advance by either party for terminating their respective obligations, may terminate this arrangement.
13. In case of any disputes arising out of obligations on each party as per this agreement, the same shall be as far as possible, be settled by mutual negotiation. In case of failure of negotiations, an arbitrator from each side will be nominated who will resolve the issue by mutual discussions, as per Arbitration & Conciliations Act 1996. The decision of arbitrator shall be final binding on both the parties. The seat of arbitration shall be Shimoga.
